ROLL CALL

CALL TO ORDER

The ESD 112 Board of Directors Business meeting was called to order by Mark Hottowe, *President*, at 3:01 pm on June 27, 2023. A quorum of six members was present.

RETIREMENT RECOGNITION

Richard Glinert, *Special Education Teacher – Ocean Beach School District*, and Steve Hertel, *School Bus Driver*, were recognized as retirees and thanked for their years of service to ESD 112.

REPORTS AND DISCUSSION

- <u>Program Highlight: Early Intervention Services</u>: Carol Hall, *Director of Early Intervention*; Deanna Doerk, *Early Intervention Program Coordinator*; and Kati Perrin, *Early Intervention Specialist / Lead Evaluator*; shared an overview of ESD 112 Early Intervention Services. ESD 112 has provided early intervention services for over 25 years and currently serves 426 children in Clark, Klickitat, Skamania, and Pacific Counties. Early intervention staff make approximately nine hundred visits each month. Children are eligible for services based on a developmental delay, disability, or health condition that may affect their development and learning. Therapy is delivered in natural environments such as the home or child care.
- <u>Early Head Start & ECEAP Program Monthly Report</u>: Jackie Brock, *Education & School Readiness Manager*, reviewed highlights of the monthly report which included information on new funding from DCYF for 36 ECLIPSE slots beginning on July 1, 2023, which will help to provide additional supports to ECEAP and early ECEAP students with complex needs.
- <u>First Reading Policy 5411 Vacation</u>: Marnie Allen, *Assistant Superintendent of Human Resources, Legal Services, and Insurance Programs*, reviewed proposed changes to Policy 5411 which will align the policy to the new salary schedules.
- <u>Superintendent's Report</u>: Tim Merlino, *Superintendent*, briefed the board on the following:
 - <u>CSG Update</u>: CSG was awarded new contracts for Fife and Inchelium School Districts and will answer RFQ's for Richland, Oak Harbor, Meridian, and Taholah School Districts.
 - <u>New Grant Funding</u>: New funding was awarded through a DCYF My Jobs Workforce Grant for \$1.64 million over two years to provide services within the juvenile justice system at Echo Glenn, Green Hill, and in group homes. Job exploration counseling and post-secondary services will be provided to approximately two hundred youth.
 - Safety Net: ESD 112 secured \$2.68 million in Safety Net funding.
 - <u>Board Elections</u>: Superintendent Merlino shared an overview of the timeline for this year's ESD board elections which will be conducted by WSSDA for the first time.

- <u>Communications Awards</u>: The ESD 112 Communications Team was awarded a Platinum Team Achievement Award by the International Hermes Creative Awards, as well as a Golden Achievement Award and Award for Excellence from the National School Public Relations Association. All three awards are the highest that can be achieved by an organization.
- <u>New Superintendents</u>: White Salmon Valley School District has hired Rich Polkinghorn as the new superintendent. Toutle Lake School District has selected Scott Fenter to serve as interim superintendent in the upcoming year. Kalama School District has also selected an interim superintendent, Jennifer McCallum.
- <u>Board Calendar</u>: Superintendent Merlino reviewed the proposed board meeting highlights for the 2023-24 School Year.
- <u>New Carpeting</u>: New carpeting will be installed in the 2500 Building over an 18month period beginning on the week of July 3-7, 2023.
- <u>Employee Acknowledgements & Recognition:</u> Monique Dugaw, *Executive Director of Communications and Public Relations,* recognized Colleen Wahto, Lisa Alexander, Susan Peng-Cowan, Gahlya Auel, the Specialized Transportation program, and the Career Connect Team SW team.
