

# ESD 112 Board of Directors Business Meeting April 22, 2025

## **ROLL CALL**

#### **CALL TO ORDER**

The ESD 112 Board of Directors Business meeting was called to order by Heidi Rosenberg, *President*, at 3:01 pm on April 22, 2025, with a quorum of five members present.

#### **REPORTS AND DISCUSSION**

- Early Care & Education Budget Update: Jodi Wall, Executive Director of Early Care & Education, shared an update on the ESD 112 Early Care and Education (ECE) programs, including a recap of the ESD's history of providing support to the community since 1985. ECE services are provided for 1,200 children by seventy-five ESD staff and two hundred contracted employees through SELF. Anticipated and potential budget cuts were reviewed. Next month, the board will review the Early Head Start grant application for renewal.
- <u>Early Head Start & ECEAP Monthly Report:</u> Jodi Wall, *Executive Director of Early Care & Education*, shared highlights of the report.
- <u>Superintendent's Report</u>: Tim Merlino, *Superintendent*, briefed the board on the following:
   <u>Legislative Update</u>: The legislative session is scheduled to end this Sunday, April 27, 2025,
   but a special session may be needed to finalize the state budget.
  - <u>ESA Update</u>: Bridgeport School District has contacted the agency regarding interest in joining the Special Education ESA.
  - <u>Federal Issues:</u> Superintendent Merlino shared that payments have been delayed for some federally funded programs in the agency.
  - <u>Annual Superintendent Evaluation</u>: The board reviewed the proposed timeline for the annual superintendent evaluation.
  - <u>Local Levy Elections</u>: Battle Ground and Hockinson School Districts are running levies in the current election.
  - <u>New Superintendents in Region</u>: An update was shared regarding new superintendents who have been hired in the region for the upcoming school year.
- Employee Acknowledgements & Recognitions: Monique Dugaw, Executive Director of Communications & Public Relations, recognized Christine Katon, Youth Workforce Program Manager; Deanna Conwell, Youth Workforce Program Coordinator; and Micah Segura-Mitchell, Youth Workforce Specialist Juvenile Rehabilitation. All were awarded a Juvenile Rehabilitation coin in recognition of their partnership with the Juvenile Rehabilitation program and their commitment to the MyJOB program. Coins are issued as a token of accomplishment, achievement, and appreciation.
