CALL TO ORDER

The ESD 112 Board of Directors Business meeting was called to order by LeAnne Bremer, *Vice-President*, at 12:14 pm on December 10, 2024. A quorum of five members was present.

REPORTS AND DISCUSSION

- ESD Connects Report: Mike Nerland, Assistant Superintendent of Teaching & Learning, introduced David Bower and Abram Krebs to share highlights of projects and events coordinated by ESD Connects over the last year, which included seven staff events and several charitable giving opportunities. Connects has also continued its tradition of organizing annual holiday giving campaigns. In 2023, fourteen families that are served by ESD programs were given \$1400 in grocery gift cards and seventy holiday gifts by staff members. The drive is still in progress this year. ESD Connects members were thanked for their efforts by the Board of Directors.
- Superintendent's Report: Tim Merlino, Superintendent, briefed the board on the following:
 - Communications Team: Monique Dugaw, Executive Director of Communications & Public Relations, recently presented at the WSSDA Conference regarding Levy & Bond communications. After her presentation, several additional districts contacted her for more information on contracts for levy and/or bond communication support. So far, fourteen districts have contracted with the ESD for communication support for February elections.
 - <u>Law Enforcement Public Information Officers</u>: The communications team organized a
 meeting between districts and law enforcement public information officers to discuss how
 they can better collaborate with each other. The group will meet twice a year moving
 forward.
 - <u>AESA National Conference</u>: Heidi Rosenberg, Superintendent Merlino, and Marnie Allen, *Assistant Superintendent for Human Resources & Insurance Programs*, attended the AESA National Conference in Orlando last week. They shared an update on the conference keynotes and breakout sessions.
 - <u>State Budget Update</u>: Due to reduced revenue, the state is anticipating a \$10-15 billion shortfall. State agencies have been asked to begin identifying budget reductions.
 - <u>District 5 Vacancy</u>: The board will interview a candidate at the January business meeting.
 - <u>Holiday Closure</u>: The main campus will be closed to the public December 23, 2024, through January 1, 2025. The agency recarpeting project will continue during this time.
- <u>Employee Acknowledgements & Recognitions</u>: Monique Dugaw, *Executive Director of Communications & Public Relations*, recognized Tuan Nguyen and Steve Ibarra in the IT department for their work supporting La Center School District.
