

Notice is hereby given the Board of Directors for the Educational Service District 112, ESD112, Vancouver, Washington, is soliciting competitive bids from responsible contractors for the renovation of our 49th Center located at 14819 NE 49th St B, Vancouver, WA 98682. ESD112 will receive sealed bids for the renovation on Friday, June 3rd, 2022, until 2:00:00 PM at the following location:

Bids must be submitted on the proper bid form, in a sealed envelope with the name of the Project and the Name of the Bidding entity clearly labeled on the front of the envelope. Bids will then be publicly read aloud after the time stated for closing of receipt of bids. Bids received after the appointed time set for receipt will be returned to the bidder unopened. All work will be under a single contract. The estimated project cost is \$800,000. A 5% bid bond is required and shall be included in the bid and made payable to Educational Service District 112 in the form of a Cashier's Check or Money Order. Bid security shall be forfeited as damages should the bidder neglect or refuse to enter into a contract and provide a suitable bond for performance and payment for labor and materials. In addition, each bid shall include a non-collusion acknowledgement.

The primary project scope includes: Work consists of interior demolition of some walls and suspended ceilings per the drawings. There will be significant plumbing work to add several restrooms with some minimal framing to add new dividing walls. We will be raising the existing suspending ceiling system from 8 feet up to 10 feet and there will be some minimal electrical work and some re-locating of HVAC ducting for the new areas. There will be some new finishes & basic generic cabinetry for renovated rooms per the details & drawings.

Notice to Proceed is anticipated on or before June 6th, 2022. Substantial Completion is established for August 15, 2022. Final completion shall be no later than 30 days after substantial completion.

Attention is called to State of Washington statutes, regulations and rules pertaining to, but not limited to the following for public work projects: non-discrimination in employment and facilities; rates of payment for prevailing wage and fringe benefits to workers; apprenticeship utilization; forms of bids; bonds; contracts; certificates' restrictions of lien; taxes and retainage; and barrier-free facilities for the accessibility requirements.
